I am requesting an investigation into the 12a to 8a shift. There are 2 new officers on this shift that are to be trained by the above officers. I have been told of several card games that are being played on this shift. I have been told a table was brought in to the jail for these games to be played on. I have an officer who has been on this shift for approx. 5 weeks and this has been going on during this time period. I have just sent a brand new officer on the shift and within a few days of him being on the shift a game was again played. I am also being told a statement by 1 of the above named officers was directed to the 2 new officers "you can't say anything about this because we could lose our jobs for doing this."

On this date 3/13/2022 for example officer Washburn came into work at 4p. He was working for officer Dailey. When Officer Dailey came to work Officer Washburn never left. He stayed the entire shift which was not necessary. Officer Ferranti came in at 7p when he was not scheduled to be here until 12p. Officer Ferranti stay in the control center with Officer Washburn. I understand the card game was played when Officer's McCullough and Dailey left the jail. I am being told that card games and movie watching goes on during the midnight shift. I understand that this is a very dead shift sometimes but, I have 1 relatively new officer and another brand new one and this is how they are being taught to work on midnights. I am concerned that when the time comes for these 2 officers to work by themselves they will do something wrong or even worse because they haven't been taught properly someone gets hurt, Staff or Inmate. My big concern is that the senior staff is sitting and relying on the new staff to do all the work.
