Judge Ade-Harlow and Attorney Hanlon,

I am emailing to document a few things Elizabeth and I discovered since starting last week in Shelby County as Special Prosecutors.

First, as you are both aware, when Elizabeth and I physically came into the office and accessed the email accounts "shcoasa@shelbycounty-il.gov" and "statesattorney@shelbycounty-il.gov" we found a large number of emails in the Delete folder of Outlook. Efforts were made to move those emails for preservation. I checked "shcoadm@shelbycounty-il.gov" which is the email address for the Administrative Assistant's computer and found over 4000 emails in the Delete folder. Those emails have yet to be moved out of the "delete" folder. I also checked the email address for the Victim Witness Coordinator shcovwc@shelbycounty-il.gov and found approximately 50 emails in the delete folder, there are 4000+ emails in the inbox folder.

Regarding the email account for the Victim Witness Coordinator, Melanie Long (the Moultrie County VWC who is helping us here in Shelby) found several emails related to outstanding bills. These emails were unopened prior to today and were received on January 31, 2023. Please advise how you would like us to proceed regarding outstanding bills.

Elizabeth and I have also found that all documents (letters, charging documents, motions, subpoenas, orders, FOIA responses, press releases, etc.) have been deleted from Ms. Kroncke's and Mr. Scott's computers. Elizabeth has brought a copy of charging documents, motions, etc. from Moultrie County and we can upload copies so Mr. Hanlon will not need to start from scratch.

There are some physical files for pending cases that Elizabeth and I have looked for in the office and have not yet been able to find. One such file Ms. Kroncke asked to remain as Special Prosecutor on so she likely has that file. We will make a list of the files that haven't been located for Mr. Hanlon to review. To the extent that we can recreate those physical files, we will.

Ms. Kroncke and Mr. Scott did not leave any forwarding information for the incoming State's Attorney should he have any questions however we received information from the Court that Ms. Kroncke might be able to be reached through the Fayette County State's Attorney's Office as she has cases as a Special Prosecutor there.
