INFORMATION

The State's Attorney, Robert T. Hanlon, of and for Shelby County, IL charges and informs the court:

COUNT 1
PREDATORY CRIMINAL SEXUAL ASSAULT OF A CHILD

That on or about March 2016 – August 2016, in Shelby County, IL, the defendant, CLINTON G. MILLER, III, committed the offense of **PREDATORY CRIMINAL SEXUAL ASSAULT OF A CHILD**, in that the said defendant, who was 17 years of age or older, committed an act of sexual penetration with C.N.R., a female child, who was under 13 years of age, in that the defendant penetrated the sex organ of C.N.R. by placing his finger in the sex organ of C.N. R. in violation of Act 5 Section 11-1.40(a)(1) Chapter 720, of the Illinois Compiled Statutes, a Class X Felony.

Minimum: 6-60 years incarceration
Extended Limitations 720 ILCS 5/3-6(j)(1)

COUNT II
PREDATORY CRIMINAL SEXUAL ASSAULT OF A CHILD

That on or about March 2016 – August 2016, in Shelby County, IL, the defendant, CLINTON G. MILLER, III, committed the offense of **PREDATORY CRIMINAL SEXUAL ASSAULT OF A CHILD**, in that the said defendant, who was 17 years of age or older, committed an act of sexual penetration with C.N.R., a female child, who was under 13 years of age, in that the defendant penetrated the sex organ of C.N.R. by placing his sex organ on the sex organ of C.N. R. in violation of Act 5 Section 11-1.40(a)(1) Chapter 720, of the Illinois Compiled Statutes, a Class X Felony.

Minimum: 6-60 years incarceration
Extended Limitations 720 ILCS 5/3-6(j)(1)

COUNT III
AGGRAVATED CRIMINAL SEXUAL ABUSE

That on or about March 2016 – August 2016, in Shelby County, IL, the defendant, CLINTON G. MILLER, III committed the offense of AGGRAVATED CRIMINAL SEXUAL ABUSE, in that the said defendant, who was 17 years of age or older, committed an act of sexual conduct with C.N.R., a female child, who was under 18 years of age, in that the defendant knowingly fondled the breasts C.N.R. with his hand, for the purpose of sexual arousal of the defendant, and the defendant held a position of trust, authority, or supervision in relation to C.N.R. in violation of Act 5 Section 11-1.60(f) Chapter 720, of the Illinois Compiled Statutes, a Class 1 Felony.


Minimum: 4-15 years incarceration
Extended Limitations 720 ILCS 5/3-6(j)(1)
