Comes now JAIME GOGGIN, hereinafter referred to as "Objector", and for his objection to the nominating papers and petitions of DWIGHT KAY, a potential candidate for the office of Madison County Board Member, Edwardsville District 24, for the Republican Party in Madison County, Illinois in the General Primary Election to be held on March 19, 2024, states as follows:


1. JAIME GOGGIN resides and is registered to vote at 306 Valley View Dr., Edwardsville, Illinois 62025.
2. DWIGHT KAY has filed nominating papers/petitions with the Madison County Clerk to appear on the ballot as a candidate for the office of Madison County Board Member, Edwardsville District 24, for the Republican Party in Madison County, Illinois in the General Primary Election to be held on March 19, 2024.
3. In raising his objection to the nominating papers and petitioners of DWIGHT KAY, Objector has an interest in seeing that the election laws of Illinois are upheld and that only property qualified candidates appear on the ballot.

4. The Statement of Candidacy submitted by DWIGHT KAY was notarized on March 23, 2023 far in advance of the first date to circulate petitions and collect signatures General Primary Election to be held March 19, 2024.
5. Page 1 of County Board Member Primary Petition of Dwight Kay for the General Primary Election to be held March 19, 2024 was notarized on March 23, 2023 far in advance of the first date to circulate petitions and collect signatures General Primary Election to be held March 19, 2024.
6. The Statement of Economic Interests to be filed with the Madison County Clerk submitted by DWIGHT KAY indicates that he was filing for the office of Precinct Committeeman and as such failed to file as a candidate for Madison County Board Member.
7. On all four of the County Board Member Primary Petition sheets submitted by DWIGHT KAY, he failed to indicate on the top portion of the page whether he lived in the city, village or unincorporated area of Glen Carbon.

REQUEST FOR RELIEF: JAIME GOGGIN requests that his objection be sustained, that a finding be made that DWIGHT KAY did not comply with the Illinois Election Code by having his Statement of Candidacy and Page 1 of County Board Member Primary Petition for Dwight Kay for the General Primary Election to be held March 19, 2024 was notarized on March 23, 2023, Page 4 of County Board Member Primary Petition of DWIGHT KAY for the General Primary Election to held March 19, 2024 was notarized on February 3, 2023, the Statement of Economic Interests to be filed with the Madison County Clerk submitted by DWIGHT KAY failed state that the office he was seeking was Madison County Board Member and instead indicated that he was running for Precinct Committeeman, that on all four of his County Board Member Primary Petition

sheets, he failed to indicate on the top portion of the page whether he lived in the city, village or unincorporated area of Glen Carbon, that his nominating papers be invalidated for the reasons stated herein, and that DWIGHT KAY not be certified or appear on the ballot as a candidate for the office of Madison County Board Member, Edwardsville District 24, for the Republican Party in Madison County, Illinois in the General Primary Election to be held on March 19, 2024.
