

**DISSOLUTION OF THE INTERGOVERNMENTAL AGREEMENT BETWEEN THE
WILL COUNTY REGIONAL OFFICE OF EDUCATION AND THE GRUNDY
KENDALL COUNTY REGIONAL OFFICE OF EDUCATION FOR THE DELIVERY OF
PROFESSIONAL DEVELOPMENT SERVICES: ROE PROFESSIONAL
DEVELOPMENT ALLIANCE**

PARTICIPANTS:

The Will County Regional Office of Education and the Grundy Kendall Regional Office of Education, legal entities as established by 105 JLCS 5/3-15.15.

PURPOSE:

On May 23, 1996, the participants entered into an Intergovernmental Agreement which created the ROE Professional Development Alliance (PDA). The Intergovernmental Agreement was entered into by the Will ROE and the Grundy Kendall ROE under and by virtue of the provisions of Article VII, Section 10, the Illinois Constitution, Intergovernmental Cooperation Act. The purpose of the creation of the Professional Development Alliance was to provide the planning and delivery of professional development services under Section 2-3. 62 of the School Code, 105 ILCS 5/2-3. 62 to the local school districts under their respective jurisdictions.

Pursuant to that agreement, the Intergovernmental Agreement was able to be altered or changed upon the agreement of the participating ROE Superintendents. The Intergovernmental Agreement was to remain in force until such time as either Regional Superintendent determines to disband it. It is upon the mutual agreement of the parties that they now seek to disband the Intergovernmental Agreement and dissolve the PDA effective the end of business December 31, 2023.

DISTRIBUTION OF ASSETS AND LIABILITIES

In accordance with the terms of the 1996 Intergovernmental Agreement, the division of all assets (other than as specifically set forth below) and cash, after payment of liabilities, shall be determined on a percentage basis: 70% Will ROE, 30% Grundy Kendall ROE. Liability and lease obligations shall be met on the same basis. It is the agreement of the parties that The Will County Regional Office of Education will retain all physical equipment and technology owned or in possession of the Professional Development Alliance, with the exception of the computers used by Hallie Brenczewski and Mary Chignoli, which shall be retained by Grundy Kendall ROE.

A final audit and forensic accounting will occur by agreement of the parties. The final audit will be paid from existing PDA funds; if funds are not available the Regional Offices will bear, as per percentage responsibility stated above, audit expenses from future State funds for professional staff development purposes. In the event Regional Superintendents cannot agree on the division of assets and liabilities, appeal may be taken to an ad hoc committee of the participating Oversight Board for their review and recommendation.

PERSONNEL

Personnel employed by the PDA shall have their remaining employment contracts assumed by the respective participants per the following chart:

WINDING UP

The Participants anticipate a wind-up period following the dissolution of the Intergovernmental Agreement. The period would allow for final payments of insurance policies, including but not limited to worker's compensation, unemployment insurance and property insurance as well as remaining IMRF contributions on behalf of personnel and completion of the fiscal audit.

IMRF contributions shall be allocated between the Will ROE and the Grundy Kendall ROE on the following percentage basis: 70% Will ROE, 30% Grundy Kendall ROE.

AGREEMENT

This document is entered into as a mutual agreement of the parties. It is a complete document and contains all relevant provisions. It has been reviewed by the respective Participants and their legal counsel.

THIS AGREEMENT, AS STATED ABOVE, IS HEREBY APPROVED AND AGREED UPON ON THIS 14th DAY OF DECEMBER 2023.
