VERIFIED OBJECTOR'S PETITION

Comes now JOHN HACKETT, hereinafter referred to as "Objector", and for his objection to the nominating papers and petitions of DOUG HULME, hereinafter referred to as "Respondent", both being potential candidates for the office of Precinct Committeeman in Edwardsville Township, Precinct 5, for the Republican Party in Madison County, Illinois in the General Primary Election to be held on March 19, 2024, states as follows:


1. Objector resides and is registered to vote at 417 Grandview Dr., Edwardsville, Illinois 62025.
2. Respondent has filed nominating papers/petitions with the Madison County Clerk to appear on the ballot as a candidate for the office of Precinct Committeeman in Edwardsville Township, Precinct 5, for the Republican Party in Madison County, Illinois in the General Primary Election to be held on March 19, 2024.
3. In raising his objection to the nominating petitioners of Respondent, Objector has an interest in seeing that the election laws of Illinois are upheld and that only properly qualified candidates appear on the ballot.

4. Nominating petitions for Precinct Committeemen must contain the signatures of at least 10 qualified primary electors.
5. Respondent has filed his nominating petitions with 11 signatures.
6. Respondent has filed nominating petitions with the signature of one Kristian Hulme, having the address of 457 Buena Vista Dr. Edwardsville, Illinois. See **Exhibit A**, attached hereto.
7. The Madison County Clerk's Voter Services site lists the voter registration address for Kristian Hulme, as 456 Buena Vista Dr. Edwardsville, Illinois. See **Exhibit B**, attached hereto.
8. Respondent has filed nominating petitions with the signature of one Peter Hulme, having the address of 457 Buena Vista Dr. Edwardsville, Illinois. Exhibit A.
9. The Madison County Clerk's Voter Services site lists the voter registration address for Peter Hulme, as 456 Buena Vista Dr. Edwardsville, Illinois. See **Exhibit C**, attached hereto.
10. 10 ILCS 5/7-10 requires that petitions "shall be signed by qualified primary electors residing in the political division for which the nomination is sought..."
11. 10 ILCS 5/3-1.2 defines a qualified primary elector as "a person who is registered to vote at the address shown opposite his signature on the petition or who was registered to vote at such address when he signed the petition."

WHEREFORE, JOHN HACKETT requests that his objection be sustained, that a finding be made that DOUG HULME did not comply with the Illinois Election Code by failing to secure signatures of ten qualified primary electors and that DOUG HULME not be certified or appear on the ballot as a candidate for the office of Precinct

Committeeman in Edwardsville Township, Precinct 5, for the Republican Party in
Madison County, Illinois in the General Primary Election to be held on March 19, 2024.

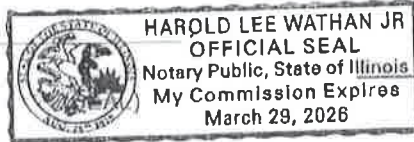

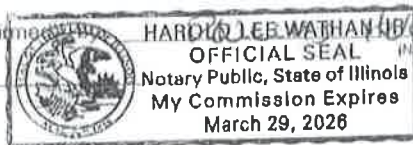
