VERIFIED OBJECTOR'S PETITION


Comes now ERIC WORTHAM, hereinafter referred to as "Objector", and for his objection to the nominating papers and petitions of LINDA WOLFE, a potential candidate for the office of Madison County Board Member, Collinsville District 22, for the Republican Party in Madison County, Illinois in the General Primary Election to be held on March 19, 2024, states as follows:

1. ERIC WORTHAM resides and is registered to vote at 1315 Deerfield Lane, Collinsville, Illinois 62234.
2. LINDA WOLFE has filed nominating papers/petitions with the Madison County Clerk to appear on the ballot as a candidate for the office of Madison County Board Member, Collinsville District 22, for the Republican Party in Madison County, Illinois in the General Primary Election to be held on March 19, 2024.
3. In raising his objection to the nominating papers and petitioners of LINDA WOLFE, Objector has an interest in seeing that the election laws of Illinois are upheld and that only property qualified candidates appear on the ballot.

4. On her Statement of Candidacy, LINDA WOLFE failed to list the office for which she was seeking election for.
5. On her Statement of Candidacy and on all five of her County Board Member Primary Petition sheets, LINDA WOLFE failed to state whether she lived within the city, village or unincorporated area of Collinsville.


REQUEST FOR RELIEF: ERIC WORTHAM requests that his objection be sustained, that a finding be made that LINDA WOLFE did not comply with the Illinois Election Code by failing to list the office she was running for on her Statement of Candidacy, failing to state whether she lived within the city, village or unincorporated area of Collinsville in her Statement of Candidacy and all five of her County Board Member Primary Petition sheets, that her nominating papers be invalidated for the reasons stated herein, and that LINDA WOLFE not be certified or appear on the ballot as a candidate for the office of Madison County Board Member, Collinsville District 22, for the Republican Party in Madison County, Illinois in the General Primary Election to be held on March 19, 2024.
