COUNT 1 THREAT OF TERRORISM

That on or about November 7, 2023, in Shelby County, IL, the defendant, **THOMAS R**. **WHEELER**, committed the offense of **THREAT OF TERRORISM**, in that the said defendant, with the intent to intimidate or coerce a significant portion of a civilian population of Moweaqua, Illinois he knowingly held a gasoline dispensary Nozzle at the Casey's gas station in Moweaqua and at the same time held a lit book of matches and thereby caused a reasonable expectation or fear of the imminent commission of a terrorist act (the potential explosion of the Casey's Gasoline Station) in violation of 720 ILCS 5/29D-20). (a Class X Felony).

COUNT II ATTEMPTED MURDER

That on or about November 7, 2023, in Shelby County, IL, the defendant, **THOMAS R. WHEELER**, committed the offense of **ATTEMPTED MURDER**, in that the said defendant, with the intent to commit a murder he knowingly held a gasoline dispensary Nozzle at the Casey's gas station in Moweaqua and at the same time held a lit book of matches and pointed the gasoline dispensary nozzle in the Direction of Chief Chris Hale of the Moweaqua Police Department and Depressed the Handle dispensing gasoline in the direction of Chief Chris Hale which was a substantial step toward the Murder of Chief Chris Hale in violation of 720 ILCS 5/8-4 (attempt). (A Class X Felony 20-80 years).

COUNT III AGGRAVATED BATTERY

That on or about November 7, 2023, in Shelby County, Illinois, the defendant, **THOMAS R. WHEELER**, committed the offense of **AGGRAVATED BATTERY**, in that the said defendant, in committing a battery, in violation of 720 ILCS 5/12-3(a)(2), knowingly made contact of an insulting or provoking nature with Chief Chris Hale, in that he made harmful or offensive contact with Chief Chris Hale, knowing Chief Hale to be an employee of the Moweaqua Police



Department, a Chief of Police, who was engaged in the execution of his authorized duties as such an employee; in violation of 720 ILCS 5/12-3.05(d)(4)(i). (Class 2)




