## Purpose:

Attempt to locate Kaylee M. Carruthers

SYNOPSIS:

On August 12, 2020, the Illinois State Police, Division of Criminal Investigation, Special Investigations Unit, was made aware of an allegation of Official Misconduct, Indecent Solicitation of an Adult, Intimidation, and Bribery against Coles County Assistant State's Attorney Brady Allen. According to the allegation, Allen contacted defendant Kara Chumbley via text message while she was in court and he was prosecuting the case against her alleging Driving Under the Influence. Allen also allegedly sent text messages to Chumbley to the effect of "you can come over tonight and we can discuss while you're riding me," and "I can give you advice while I'm giving you a mouthful."

DETAILS:

The purpose of this investigative report is to document the attempt to locate Kaylee M. Carruthers (F/W, DOB: 07/16/99). Reference TN: 24 – Brianna Lee said Carruthers allegedly had sex with Brady Allen in his office to get leniency for a felony charge. Lee said this allegedly occurred in or around March 2020. I, Sergeant Windy Westfall #5210, attempted to locate Carruthers to either confirm or dispute that allegation. I conducted the following attempts to locate Carruthers to no avail:

- February 1, 2023: I called Carruthers' last known phone number ((217) 246-2025). A man answered, and I asked to speak with Carruthers; he said I had the wrong number. I then sent Carruthers an email at kayaar2015@gmail.com I never received a response.
- February 16, 2023: One of Carruthers' last known addresses was 309 W. College Ave., Apr. 1, Greenville, IL. I called the Greenville Police Department, and they had no documentation of Carruthers.
- May 23, 2023: I obtained a supposed more recent address for Carruthers (1613 N. 19<sup>th</sup> Street, Springfield, IL). Special Agent Nate Baker #5488 and I went to that address. The residences, Joseph Pope and Stephanie Stanley, said Carruthers used to live there with them but they kicked her out in 2018. Pope's son and Carruthers have a child together. Pope thought Carruthers is currently living in Florida. Pope took my business card and said he would try to find an address or phone number for Carruthers and let me know.

As of today, I have not received any updated information on Carruthers' whereabouts.
