Ms. Fox,

Please find attached a petition for special meeting. Please forward this to the board for additional requests.

Ms. Woolery discovered that her line item for ASA that had a budget of \$124,800 and was 40.68% spent on April 30<sup>th</sup> is now overspent by \$4,614.80. She is asking for a meeting to discuss her budget and the attached form is a petition for a special meeting to meet her request. With a pending murder trial and other issues in her office, the absence of a qualified ASA will likely hamstring her capabilities as well as place a heavy burden on the court system and local law enforcement efforts.

I would urge the board to review 5 ILCS 415/1 (Government Severance Pay Act). The last sentence of Section 5 states this statute applies to local units of government. Section 10 provides guidelines for severance, to include entering into an agreement, pay not exceeding 20 weeks of compensation, as well as no obligation to provide severance in absence of a contract.

In addition, please review 720 ILCS 5/33-3 (Official Misconduct). I point this out to ensure that we are all looking at ourselves to ensure that actions being taken and reactions to actions are legal to avoid misconduct.

I urge a special meeting to begin this discussion of the budget and the activities surrounding the ~\$91,950 of expenditures in the SA office on May 10<sup>th</sup>.
