Dear Mr. Scott:

The Public Access Bureau has received the enclosed Requests for Review in which Mr. Bradley VanHoose and Mr. John Kraft allege that the Village of Caseyville Board of Trustees (Board) violated the Open Meetings Act (OMA) (5 ILCS 120/1 *et seq.* (West 2022)). In their Requests for Review, Mr. VanHoose and Mr. Kraft allege that at the July 3, 2024, meeting, the Board discussed topics beyond the scope of the cited exceptions for entering closed session. This office has determined that further inquiry is warranted.

To further evaluate this matter, please provide this office with copies of the July 3, 2024, meeting agenda, open and closed session minutes, and the verbatim recording of the closed session for this office's confidential review. Please provide a copy of the recording of the open session of the meeting, if one exists. Please also provide a written response describing the Board's public recital made pursuant to section  $2a^1$  of OMA and identify the specific exception(s) in section  $2(c)^2$  of OMA that the Board publicly cited as its basis for entering closed session during its July 3, 2024, meeting. Please explain how that exception, or any other exception listed in section 2(c) of OMA, applied to the Board's closed session discussion.

As we conduct our review of this matter, we will notify you if we need to review additional records or information. You have the option under the Act to provide a written response to these allegations in addition to the requested materials. That response may take the form of a letter, brief or memorandum. Please note that under the Act, we are required to forward a copy of any response from a public body to the requester and provide the requester an opportunity to reply. 5 ILCS 120/3.5(c) (West 2022). The Act also permits a public body to provide a copy of a response with confidential information redacted for release to the requester. If you claim that any portion of your written response is confidential, please send two versions of your response letter: a complete copy for this office's confidential review and a redacted version suitable for this office to forward to the requester. If you believe that other documents or information would be helpful to us as we review the issues, you may submit additional records or affidavits.
