#### **COMPLAINT DESCRIPTION**

This has been mentioned to Jeff Johnson, Mayor of Shelbyville in an open council meeting about having independent audits done. A church in Shelbyville is being charged for a 2 inch meter for many years, and they only had a 1 inch meter, roughly \$100 a month difference. The lead who runs the water office is the mayor's sister, which is suspicious because they were made aware of it, but have made no effort to reimburse them for the many dollars that have been paid in the past for the wrong size meter. The water department lead has altered meter readings for years. Since this is done by the mayor's sister, no action is taken. This is just the tip of the iceberg, if somebody will contact me, I will be glad to expound further details. An independent audit would probably find many such inaccuracies.
