Narrative

On 05/04/2025 at approximately 2:13 A.M. Kayla R. Coleman [REDACTED] [REDACTED] contacted the Christian County Sheriff's Office in reference to an altercation that occurred at the location of 306 South Business 51 Assumption, IL. Kayla advised dispatch that Angela M. Palmer [REDACTED] came up to her at the bar and struck her in the face.

Deputy I. Weddle arrived and witnessed a Red Ford F150 [REDACTED] leaving the bar. The registration belonged to Herbert Palmer, and Angela Palmer. Deputy Weddle conducted a traffic stop on the vehicle. Deputy Weddle approached the vehicle and identified the driver as Herbert Palmer. The passenger identified as Angela Palmer. Deputy Weddle advised them to pull the vehicle back into the parking lot of the bar.

I Deputy J. Davis arrived at the location. I spoke to Kayla outside of the bar in the parking area. Kayla advised that she was standing at the bar when Angela approached her. Angela then struck her in the face with her fist for some unknown reason. Kayla then made an attempt to protect her self from Angela. Kayla had marks on her neck and some discoloration on the bottom of her jaw. I then spoke to three other witnesses consisting of John Spratt [REDACTED] [REDACTED], Nicole Lowe [REDACTED] and Ryan Dailey [REDACTED] [REDACTED]. All three witnesses advised they were sitting at the bar when Angela approached Kayla and struck her in the face for no reason. Angela continued to fight with Kayla while John, Ryan, and Nicole made an attempt to brake up the altercation. After a few minutes the two females were separated prior to our arrival.

I spoke to the bar owner by the name of Erica Burner. Erica obtained the surveillance footage from the bar area. The surveillance footage showed Kayla standing at the end of the bar. Angela walked out of the restroom area and looked over towards Kayla. Angela then approached Kayla and struck her in the face. The altercation then moved over by the front door of the bar. The altercation stopped and both parties exited the bar.

I exited the bar and approached Angela sitting in the passenger side of the vehicle. I assisted Angela out of the vehicle and placed her under arrest for Battery. I placed Angela in handcuffs properly fit and double locked. At that point Angela advised that she approached Kayla and struck her in the face. I escorted Angela to my patrol vehicle and placed her in the rear seat. Deputy Weddle assisted Herbert out of the drivers side of the vehicle. Deputy Weddle performed a standardized field sobriety test on Herbert. After Deputy Weddle completed the test, Deputy Weddle placed Herbert under arrest for driving under

the influence of alcohol. Deputy Weddle transported Herbert to the Christian County Correctional Facility. I remained on scene with Angela until Taylorville Towing arrived to tow the vehicle.

After the vehicle was towed, I transported Angela to the Christian County Correctional Facility. I issued Angela a notice to appear on 05/22/2025 at 1:00 P.M. for the battery charge.
