1. NOW COMES Plaintiff EDGAR COUNTY WATCHDOGS, by the undersigned attorneys Loevy & Loevy, and brings this suit to overturn VILLAGE OF OSWEGO's willful violation of the Illinois Freedom of Information Act in its refusal to produce records regarding a road rage incident in which an off-duty law enforcement officer allegedly brandished a firearm at another driver. In support of the Complaint, EDGAR COUNTY WATCHDOGS states as follows:

COMPLAINT

INTRODUCTION

- 2. At the time of the FOIA request at issue in this case has been pending, Defendant OSWEGO was aware that pursuant to the fundamental philosophy of the American constitutional form of government, it is the public policy of the State of Illinois that all persons are entitled to full and complete information regarding the affairs of government and the official acts and policies of those who represent them as public officials and public employees consistent with the terms of the Illinois Freedom of Information Act ("FOIA").
- 3. At the time of the FOIA request at issue in this case has been pending, Defendant OSWEGO was aware that restraints on access to information, to the extent permitted by FOIA, are limited exceptions to the principle that the people of this state have a right to full disclosure of

information relating to the decisions, policies, procedures, rules, standards, and other aspects of government activity that affect the conduct of government and the lives of the people.

4. At the time of the FOIA request at issue in this case has been pending, Defendant OSWEGO was aware that under FOIA Section 1.2, all records in the custody or possession of a public body are presumed to be open to inspection or copying, and that any public body that asserts that a record is exempt from disclosure has the burden of proving by clear and convincing evidence that it is exempt.

PARTIES

- 5. Plaintiff EDGAR COUNTY WATCHDOGS ("ECW") is a non-profit news media organization located in Paris, Illinois. ECW made the FOIA request at issue in this case.
- 6. Defendant VILLAGE OF OSWEGO ("OSWEGO") is a public body located in Kendall County, Illinois.

AUGUST 25, 2025 FOIA REQUEST

- 7. On August 25, 2025, ECW submitted a FOIA request to OSWEGO seeking the following records:
 - I respectfully request the following records related to an incident that occurred on or about February 27, 2025, around 4:00 p.m. in Oswego, Illinois, involving a road-rage confrontation and the alleged display of a firearm—it involved an off-duty Bolingbrook Police Officer believed to be Sal Davi:
 - 1. All incident reports, supplemental reports, officer narratives, and investigative summaries.
 - 2. Any Computer-Aided Dispatch (CAD) logs, 911 call logs, and associated radio transmissions.
 - 3. Any photographs, evidence inventories, or internal memos related to this incident.

- 4. Separately and explicitly, I request all available body-worn camera footage, dashboard camera recordings, and in-car video recordings related to this incident.
- 5. Any disciplinary findings, determinations, or administrative actions arising from this incident, if applicable.
- 8. A true and correct copy of the FOIA request, along with subsequent correspondence, is attached as Exhibit 1.
- 9. On October 6, 2025, Plaintiff sent a follow-up message inquiring about the status of the request. *Id*.
- 10. On October 6, 2025, OSWEGO withheld all responsive records pursuant to Exemption 7(1)(c), stating that "an entire police report may be withheld where no arrests were made and the matter is closed at the time of the request" in "certain limited circumstances."
 - 11. A true and correct copy of the correspondence is attached as Exhibit 2.
- 12. OSWEGO did not send any further correspondence to Plaintiff regarding this request.
- 13. At the time of the FOIA request at issue in this case has been pending, OSWEGO was aware that Section 7(1)(c) of FOIA exempts:

Personal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information. "Unwarranted invasion of personal privacy" means the disclosure of information that is highly personal or objectionable to a reasonable person and in which the subject's right to privacy outweighs any legitimate public interest in obtaining the information. The disclosure of information that bears on the public duties of public employees and officials shall not be considered an invasion of personal privacy.

5 ILCS 140/7(1)(c) (emphasis added).

- 14. Engaging in a road-rage incident and brandishing a weapon, even if off duty at the time, bears on the public duties of a police officer.
- 15. As of the date of this filing OSWEGO has failed to demonstrate how any of the information contained in the responsive records is exempt from disclosure and has furnished no evidence supporting its exemption claims.
- 16. OSWEGO's responses to the request were intentional and not issued inadvertently or by mistake.
- 17. OSWEGO's responses were consistent with and made pursuant to OSWEGO policies.
- 18. As of the date of this filing OSWEGO has failed to comply with FOIA and has not produced records responsive to the request.

COUNT I – AUGUST 25, 2025 FOIA REQUEST OSWEGO'S FOIA VIOLATION

- 19. Paragraphs 1-18 are incorporated by reference.
- 20. OSWEGO is a public body under FOIA.
- 21. The records sought in the FOIA request include non-exempt public records or portions of public records of OSWEGO.
 - 22. OSWEGO has failed to adequately search for records responsive to the request.
 - 23. OSWEGO violated FOIA by failing to produce records responsive to the request.
- 24. OSWEGO willfully and intentionally, or otherwise in bad faith failed to comply with FOIA.

WHEREFORE, EDGAR COUNTY WATCHDOGS asks that the Court:

- i. declare that OSWEGO has violated FOIA;
- ii. order OSWEGO to conduct an adequate search for the requested records;

- iii. order OSWEGO to produce all non-exempt portions of the requested records;
- iv. enjoin OSWEGO from withholding non-exempt public records under FOIA;
- v. order OSWEGO to pay civil penalties;
- vi. enter remedial injunctive relief requiring OSWEGO to cease the policies that caused the denials at issue in this case;
- vii. award Plaintiff reasonable attorneys' fees and costs; and
- viii. award such other relief the Court considers appropriate.

Thank you for contacting the Oswego Police Department with your request for information pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq.

On October 6, 2025, you requested the following documents:

I respectfully request the following records related to an incident that occurred on or about February 27, 2025, around 4:00 PM in Oswego, IL involving a road rage confrontation and the alleged display of a firearm – it involved an off-duty Bolingbrook Police Officer believed to be Sal Davi.

Your request for records is being denied under FOIA Exemption 7(1)(c), invasion of personal privacy. In certain limited circumstances, an entire police report may be withheld, where no arrests were made, and the matter is closed at the time of the request.
