

Members are from all over the United States as well as overseas (UK, Ireland, Scotland, Canada, Islands, Australia, New Zealand and Africa). During Biblical Feasts hundreds of First Harvest members come to MS to attend services held at the Community Center in Bay St. Louis and Miracle Tabernacles, United Pentecostal Church, 235 Old Spanish Trail Waveland MS (which has NO religious affiliation with "First Harvest Ministries. ") Other weeks of the year, Sabbath services are held with mostly local members, as most of the tithing/large financial contributing members are across the nation and overseas.

There are over 200 past members of First Harvest Ministries that have departed because Pastor John Shane Vaughn does NOT exude the above characteristics of a Pastor. Why not go in Peace you ask? Good Question! Always stating in his lessons "the congregation can ask me anything, I love people" but when asked anything about procedures, doctrine, his personal behavior and particularly money, he becomes angry, belligerent, combative, demeaning, resorts to name calling, shuns members and insists the current members participate in shunning.

CONCERNS:

BEHAVIOR: This Pastor is arrogant, unapproachable, boastful, quick to anger and retaliation. He shuns anyone who has left and demands Church members do the same. He screams and chastises anyone that questions him.

TAPS (TOTOS ARMY OF PATRIOTS)- Program designed to collect donations for political candidates all over the nation.. Millions of dollars were donated and went directly into Shane's personal financial accounts. There has been no proof or documentation as to where the money has gone and no board to question.

TAX EXEMPT STATUS: Shane refuses to apply for 501(c)3 status and believes he does not need one. The law still requires he adhere to the tax exempt laws if he doesn't want to pay taxes. Tithes also go into his personal financial accounts.

30 ACRE COMPOUND: Shane has purchased 30 acres of land and is developing it to be a Church compound where festivals and feasts will be held. It is also to be where several people including widows will live, some already housed there now. Church members are ordered to work on the land any given moment they are told. The land was purchased by an alleged anonymous donor, though no one has seen any proof and members have been told the donation was varying amounts.
