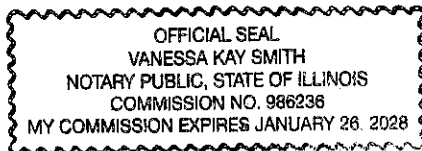
THEFT OF GOVERNMENTAL PROPERTY

in violation of **720 ILCS 5/16-1(a)(1) and (b)(6.1)**, in that said defendant, in furtherance of a single intention and design, through a series of acts, knowingly obtained unauthorized control over governmental property of Dolson Township, Clark County, Illinois said property being United States currency, having a total value in excess of one-hundred thousand dollars (\$100,000), with the intent to permanently deprive Dolson Township of the use or benefit of the property. **(CLASS X FELONY)**.




OFFICIAL MISCONDUCT

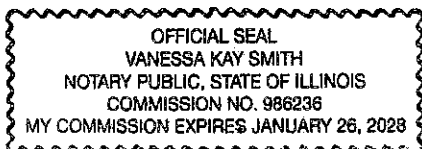
