

**ORDINANCE NO. #2026-1-15**

**AN ORDINANCE FOR THE LEVY OF TAXES  
FOR THE CLARK COUNTY PARK DISTRICT FOR THE FISCAL YEAR BEGINNING  
APRIL 1, 2025, AND ENDING MARCH 31, 2026**

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CLARK COUNTY PARK DISTRICT, CLARK, STATE OF ILLINOIS, AS FOLLOWS:

**SECTION 1.** That the sum of one hundred seventy thousand six hundred and thirteen dollars (\$170,613.00) being the total of that part of the appropriations heretofore legally made which are to be raised by taxation for the current fiscal year beginning the 1<sup>st</sup> day of April, 2025 and ending the 31<sup>st</sup> day of March, 2026, by Clark County Park District for all corporate purposes of said Park District and for purposes of providing for a Corporate and Recreation Fund, Liability Insurance Fund, Audit Fund, Illinois Municipal Retirement Fund and Paving and Lighting Fund be and the same is hereby levied upon all taxable property within said Park District subject to taxation for said fiscal year. The specific amount as levied for the various purposes mentioned above are as set forth below, said taxes levied being for said current fiscal year of said District and for the said appropriations to be raised by taxation, the total of which have been ascertained as aforesaid, and being as follows:

**SECTION 2.** That the total amount of one hundred seventy thousand six hundred and thirteen dollars (\$170,613.00) ascertained as aforesaid, be and the same is hereby levied and assessed on all property subject to taxation within the Clark County Park District according to the value of said property as the same is assessed and equalized for the State and County purposes for the current year.

**SECTION 3.** That there is hereby certified to the County Clerk of Clark County, Illinois, the several sums aforesaid constituting said total amount of one hundred seventy thousand six hundred and thirteen dollars (\$170,613.00) which said total amount the said Clark County Park District requires to be raised by taxation for the current fiscal year of said Park District, and the Secretary of said District is hereby ordered and

directed to file with the County Clerk of said County on or before the time required by law, a certified copy of this Ordinance.

**SECTION 4.** This Ordinance shall take effect and be in full force and effect immediately upon and after its passage and approval.
