RE: FOIA Request

Dear Mr. Allen,

Thank you for writing to the Clark County State's Attorney's Office with your request for information pursuant to the Illinois Freedom of Information Act ("FOIA"), 5 ILCS 140/1 et seq.

On December 29, 2025, you requested the following information:

1. **A copy of all records provided to the office of State's Attorney by the Illinois State Police regarding a criminal investigation connected to Dolson Township and its Supervisor and Clerk.**
2. **A copy of all emails to and from the Illinois State Police related to the criminal investigation into Dolson Township.**

Your requests is **granted in part and denied in part**. Attached please find 353 pages regarding your request. Certain records, or portions thereof, are withheld or redacted pursuant to the exemptions set forth below.

**First**, pursuant to 5 ILCS 140/7(1)(d)(iii), records may be withheld where disclosure would create a substantial likelihood that a person will be deprived of a fair trial or an impartial hearing. The investigation at issue has progressed to a stage at which prosecutorial review and charging decisions are actively being considered. Disclosure of investigative records at this juncture would create a substantial likelihood of prejudicing future judicial proceedings by publicly disseminating untested allegations, investigative conclusions, and credibility assessments that would not be subject to the evidentiary safeguards of a court proceeding. The requested records include witness statements, law enforcement evaluations, and investigative summaries that reflect preliminary findings and unresolved factual disputes. Public disclosure of such materials would risk tainting the potential jury pool by exposing information that may ultimately be excluded, limited, or presented in a different context at trial, thereby undermining the integrity of jury selection and any defendant's right to an impartial hearing.

**Second**, 5 ILCS 140/7(1)(d)(iv) provides that records in the possession of any public body created by any law enforcement agency for law enforcement purposes may be exempt if such information would unavoidably disclose the identity of a confidential source, or persons who file complaints with or provide information to law enforcement. Portions of the documents you are requesting would disclose the identity of persons who have provided information to law enforcement, and therefore, are exempt from disclosure.

**Third**, disclosure would also interfere with active law enforcement proceedings under 5 ILCS 140/7(1)(d)(vii). The requested materials contain non-public investigative details, including the scope and direction of the investigation and statements obtained from witnesses who may be re-interviewed or called to testify. Release of this information would compromise the effectiveness of ongoing investigative efforts by revealing evidence, discouraging cooperation, and influencing future witness testimony.

**Fourth**, 5 ILCS 140/7(1)(b) exempts “private information” unless disclosure is required under another provision of the Act. “Private information” is defined in 5 ILCS 140/2(c-5) as unique identifiers, including a person’s social security number, driver’s license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Portions of the responsive records contain such information and have been redacted accordingly.

**Fifth**, 5 ILCS 140/7(1)(c) exempts “personal information” contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, absent written consent. Certain records contain personal information, including but not limited to, financial account information and other personal data, the disclosure of which would constitute such an invasion of privacy.

Please note that the denial of portions of your request is based on the timing of the request rather than the nature of the records themselves. Upon the conclusion of the investigation and any related judicial proceedings, the applicability of FOIA exemptions may be reevaluated consistent with the Act.

You have a right to have the denial of your request reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a). You can file your Request for Review with the PAC by writing to:

You also have the right to seek judicial review of your denial by filing a lawsuit in the State circuit court. 5 ILCS 140/11. If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days of the date of this denial. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original FOIA request and this denial letter when filing a Request for Review with the PAC.
