OFFICER NARRATIVE

On 02-27-2025 at 1603 hours, I, Officer Watson, O-67, Officer Dickey, O-25, Officer Garcia, O-47, Officer Catberro, O-46, and Sgt. Most, O-37, were dispatched to an armed threatening where both vehicles involved were now pulling into Oswego East High School. It was soon after found that it was not Oswego East High School and both vehicles were now parked at Oswego High School, 4250 Route 71, Oswego, IL. Kencom advised that a male in a black Range Rover had a gun.

It should be noted that when this call was dispatched, I was at the Oswego Police Department and mistakenly left without my body worn camera, therefore, footage from my point of view was not captured.

Officer Dickey and Officer Garcia were first on scene and were positioned behind the black Range Rover, bearing Illinois registration [REDACTED], with their duty weapons drawn. Officer Dickey told the male, later identified as Salvatore D. Davi Jr, m/w, [REDACTED], phone number [REDACTED] to put his hands out the window to show he did not have a firearm. Salvatore complied and was yelling to Officer Dickey that he was an off-duty police officer.

Upon my arrival, I stacked up behind officer Dickey, as he instructed Salvatore to exit the vehicle. [REDACTED] vehicle was positioned behind Salvatore's vehicle in the parking lot. Salvatore exited the vehicle and raised his shirt to show that he did not have any weapons in his waistband. Salvatore was instructed to walk to the front of the squad car where I temporarily detained him in handcuffs. I handcuffed Salvatore with his hands behind his back and checked for proper fit. I conducted a protective pat down on Salvatore, finding no weapons and the handcuffs were removed. At this time, Salvatore was stating he was an off-duty Bolingbrook Police Officer and that his police identification card was in a black bag in his vehicle. Salvatore gave Officer Dickey consent to obtain the bag from the vehicle. Officer Dickey found his wallet and identification and confirmed Salvatore was in fact an off-duty Bolingbrook Police Officer.

Salvatore stated the following, not verbatim:

He was driving westbound Plainfield Road, where it turns into E. Washington Street, when he observed a male in a mini-van, bearing Illinois registration [REDACTED], driving erratically and passing cars in the turn lane/median at Grove Road. The male in the minivan, later identified as [REDACTED], m/b, [REDACTED], phone number [REDACTED], was in the left turn lane of E. Washington Street to turn southbound onto Route 71 and Salvatore was in the right turn lane to turn northbound Route 71. [REDACTED] windows were rolled down and Salvatore yelled at Malcolm about his erratic driving. [REDACTED] then cut across two lanes of traffic and pulled up next to Salvatore's vehicle in the turn lane. Salvatore stated he was in fear for his life when [REDACTED] quickly pulled up next to him and Salvatore grabbed his off-duty pistol from the center console. Salvatore stated he did not point the weapon at [REDACTED] but held it against his torso pointing downward. Salvatore then continued to drive to Oswego High School where he was going to pick up his son. [REDACTED] continued to follow him and drove in the center median to the left of Salvatore before both vehicles pulled into the high school parking lot. Salvatore called 911 at this time. It should be noted Blockett had no stated business at the high school or on the premises.

I then spoke with [REDACTED] who had previously gave his statement to Officer Catberro, [REDACTED] gave me the short version of events, not verbatim:

The incident started around Plainfield Road and Woolley Road when a vehicle slowed down in front of him, and he passed them. Salvatore's vehicle was in front of the vehicle he passed. Once they got near the intersection of E. Washington Street and Route 71 that is when a verbal altercation occurred. [REDACTED] was in the left turn lane and Salvatore was in the right turn lane. During the verbal altercation is when Salvatore displayed a firearm pointing it at [REDACTED]. [REDACTED] then cut across two lanes of traffic to pull up next to Salvatore and told him to shoot him because he is not afraid of guns. [REDACTED] then called 911 and followed Salvatore to Oswego High School until police arrived on scene. [REDACTED] did not wish to pursue charges and stated he just wanted to physically fight Salvatore. [REDACTED] was advised we would not allow that to happen. (See Officer Catberro's supplemental report for further information)

There were no independent witnesses or video footage available at the time of this report. Due to [REDACTED] not willing to pursue charges as well as lack of probable cause during the investigation conducted on scene, no arrest was made.

A KenCom 911 information request form was completed and submitted.

This case is closed.

On 2/27/25 at 1603 hours, I, Officer Catberro O-46, responded to Oswego High School 4250 Route 71 for a report of an armed threatening. KenCom advised someone pulled a gun on the caller and they had followed them to Oswego High School.

While on scene, I had the opportunity to speak with [REDACTED], M/B, DOB [REDACTED]. [REDACTED] advised the following in summary. He was driving NB Plainfield Road next to Prairie Point Park. While driving he was on his cell phone. [REDACTED] looked up and noticed he was about to hit the vehicle in front of him. To prevent an accident, [REDACTED] drove on the painted median and went around the vehicle in front of him. As [REDACTED] approached E. Washington and Route 71, [REDACTED] was about to get into the left turn lane. At that time a black Range Rover pulled next to him. The other driver, later identified as Salvatore D. Davi Jr., M/W, DOB [REDACTED], began yelling at [REDACTED] stating "nigga you don't want to do this" repeatedly and displayed a handgun. [REDACTED] instructed him to shoot the gun. Salvatore then proceeded NB Route 71 and [REDACTED] followed him while calling 911. They ended up in the parking lot of Oswego High School. While [REDACTED] spoke with Officer Watson, [REDACTED] stated he did not want anything done and just wanted it known that he felt threatened. [REDACTED] also stated several times on scene that he was not afraid of being shot.

It should be noted that my body worn camera was reviewed prior to writing this report and was flagged for retention.

Nothing further.

On 2-27-25 at approximately 1603 hours I Officer C.M.Dickey O-25 responded to an IREACH dispatch for a man with a firearm at the Oswego East High School. While en route to that location Ken Con changed the location the the Oswego High School.

Upon my arrival in the north parking lot, I saw a black male waving his arms and yelling. I rolled down my window and asked where the man with the gun was. The black male pointed to a nearby black Range Rover parked in a tow parking lane to the east.

I was so close to the Range Rover I immediately exited my squad car with my rifle and started giving commands. The driver complied. During this initial contact Ken Com advised that the man with the firearm was possibly an off-duty police officer. While Ken Com was dispatching the above information, the male driver was yelling out the window that he was a police officer.

The male driver and only occupant followed my instructions on exiting his car. The male subject walked back to my squad where he was placed into handcuffs and patted down for weapons with negative results by Officer Watson.

The male driver was identified as Salvatore D. Davi Jr. M/W DOB [REDACTED]

The other driver was later identified as [REDACTED] M/B DOB [REDACTED]

During this investigation, Officer Watson told me that he had forgotten his BWC as he ran out of the police department to respond to this call. He also asked for me to be present with him when he spoke with Davi to have the interaction recorded.

Davi said this all started from what he described as a road rage incident from the Plainfield/Rt 71 intersection.

During my conversation with Davi he said the following in summary and not verbatim:

He [REDACTED] sped up next to me and I didn't know what he was doing
He [REDACTED] was driving like a psycho
He [REDACTED] was driving in the center turn lane
He (Davi) pulled his gun out but did not point it at the other driver
The other driver had his window down, yelling
He didn't know what the other driver's problem was
He was not going to stand for that
He called 911 also and told them he was an officer and he was armed
He (Davi) was in fear of his life
He (Davi) decided to err on the side of caution
He [REDACTED] followed him (Davi) into the parking lot

For the actual conversation refer to the footage of my BWC that was operational and on during this incident. It should also be noted that I reviewed my BWC footage before completing this narrative.
