

SECOND AMENDMENT
to
PUBLIC-PRIVATE PARTNERSHIP AGREEMENT

This Second Amendment to the Personnel Services Contract by and between METRO PARAMEDIC SERVICES, INC., an Illinois Corporation (hereinafter referred to as "METRO" or "Contractor") and the BEECHER FIRE PROTECTION DISTRICT, (hereinafter referred to as ("DISTRICT or CLIENT")) is effective on May 1, 2026.

WITNESSETH:

WHEREAS, METRO and DISTRICT are parties to a certain Personnel Services Contract effective MAY 1, 2025 ("Contract") whereby METRO contracted to supply Personnel to the DISTRICT in accordance with the terms of the Contract for three years, beginning MAY 1, 2025 and ending APRIL 30, 2028; and

WHEREAS, pursuant to Article 8 of the Contract, the Parties have negotiated in good faith to establish the consideration to be paid to Contractor for services provided by Contractor to District for Year Two (2) of the Contract beginning May 1, 2026; and

NOW, THEREFORE, in accordance with Article 24 of the Contract and in consideration of the mutual covenants herein contained, the Parties hereby amend the Contract as follows:

1. ARTICLE 8: Consideration.

Article 8 shall be amended by inserting the following paragraph as the second paragraph of Article 8: Consideration as follows:

In consideration for the services to be provided by Contractor to the Client in Year Two (2), the Client shall pay Contractor the total sum of \$381,317.96. This sum shall be paid in twelve equal monthly payments of \$31,776.49, due and owing on the 15th of the month. Subsequent payments shall be due on the fifteenth day of each month in of Year Two (2).

Article 8 shall be amended by striking paragraph four of Article 8 (“In the event that client requests that Contractor...”) in its entirety and replaced with the following new fourth paragraph of Article 8:

New Fourth Paragraph: If Client requests that Contractor assign additional firefighter/paramedic personnel to District, or that Client requests assigned firefighter/personnel to work hours in excess of those specified in this Agreement, Client shall pay Contractor \$43.57 per hour, for hours worked in excess of those specified in this Agreement. Additional Personnel assigned to the Client shall require an amendment to this Agreement or a written executed copy of a Memorandum of Understanding (MOU) by and between Contractor and Client. Contractor shall issue an invoice for excess Personnel or excess Personnel hours, and client agrees to pay any such invoice within thirty (30) days.

Unless specifically changed in this Second Amendment, the provisions of the Contract and its First Amendment remain in effect. If any provision of this Second Amendment conflicts with the Contract, or its First Amendment, this Second Amendment shall control.
